The City completed their redistricting process. Tamarack is still in District 9; Nikki Conklin is our alder. Voters who vote at Lussier Community and Education Center are now in Ward 115. Voters who voted at High Point Church are returning to that location; they are in Ward 116.

Board and Committee Business

From Your Board of Directors...

The Tamarack Trails Board of Directors is taking steps to address important priorities for 2022. Those priorities include but are not limited to examining policy resolutions, by-laws, and the Association's Restated Declarations. Are the documents up to date? Do any ambiguities or unclear areas need editing? In doing so various committees will need to be consulted.

A second priority is to address improving Association communications. The Board will be looking at website enhancements as well as addressing ways to improve the Association's monthly newsletter, "The Good Life."

A third priority is to make sure committees have what they need to meet their goals. How might communications between the Board and committees be improved? What clarification is needed in terms of the role of our Association staff, the Board, and committee members? What can be done to recruit residents to serve on Association committees and how can barriers that restrict residents from serving be removed?

The Board is also interested in surveying residents on several topics to listen to and receive feedback from residents.

The safety of our Association and residents is a continuing concern. The Board is taking steps to make sure covid-19 safety protocols are followed. That includes adding an addendum to the Employee Handbook making sure staff members are vaccinated or test negative for covid-19 as a working condition.

Public safety related to criminal activity is another concern and is a frequent topic of conversation during Board meetings. The Strengthening Ties Together work group continues to explore ways to collaborate with our neighboring associations in efforts to provide information to us on a number of public safety issues.

What About Those Assessments?

You recently received your 2022 Annual Monthly Assessment (AMA) or monthly fee and you may be wondering, "Why the increase?" On behalf of the Board of Directors, this article will explain why the AMA is necessary, how it's calculated, and what's different this year.

Background: Here at TT, about 70% of AMA money is used to pay for annual operating expenses such as staff wages, snow removal, lawn care, minor repairs and maintenance, etc. The remaining 30% is kept in a reserve account to pay expenses that don't occur every year such as replacement of roofs, siding, asphalt, sewer lines, etc. Some housing associations ignore the second part and impose special assessments, as needed, to pay for large projects. By planning ahead, TT seeks to eliminate worry about sudden, large assessments and ensures generational equity. In some years more money is taken out of the reserve account than goes in and in other years it's the reverse. TT's goal over the long term is to have money available in the reserve account when needed. The most recent example was TT's ability to finance the bioswale project from the reserve account.

Principles: The calculations that make up your AMA are complex, but the principles are not. TT costs are broken into several categories and costs in each category are assigned to individual units based on each unit's characteristics.

- All units have a roof and siding so those costs are split up based on the square footage of each unit's roof and siding.
- The costs of decks and patios are assessed only to units that have decks and patios.
 Units with bigger decks and patios pay higher costs.
- Costs for common facilities (pool, clubhouse, tennis courts, walking paths, fences, signs and maintenance buildings) are assigned to all units equally.
- TT property insurance covers replacement costs of all 320 living units. Insurance premiums are allocated to units based on estimated replacement costs for each unit.
- Grounds maintenance and asphalt replacement are calculated separately for each of TT's seven phases of development. Some phases are more densely built up than others. More density means less grounds maintenance and asphalt replacement per unit.

What's new this year: The cost of material and labor has increased with inflation, but the single biggest contributor to the increase is the surge in property insurance premiums. After several years of fires and floods, insurance companies nationwide have become more selective in the risks they're willing to cover. The cost to insure TT's living units and common facilities increased by more than a third from 2021 to 2022, raising the average AMA by over \$15 per month or 80% of the average increase. The burden fell more heavily on larger units because replacing them is more expensive. The 2022 increase for the average unit was \$19.32 or 5%.

SNOW SHOVELING ON 01-23-2022-THANK YOU!

Free at-home COVID-19 tests

Every home in the U.S. is eligible to order 4 free at-home COVID-19 tests. The tests are completely free.

COVIDtests.gov

The website is up and running. They have tests for every residential address in the U.S. Orders will usually ship in 7-12 days. The website only asks for your name, shipping address, and *email* (if you want shipping notifications from the post office).

The tests are rapid antigen "at-home" or "self" tests — not PCR tests which require a lab dropoff. The "at-home" or "self" tests can be taken anywhere and give results within 30 minutes.

Guard against scammers trying to steal your personal information. When ordering tests, use the official, secure government website: https://COVIDtests.gov. **Watch out for phone scammers, too.** If you get a phone call requesting information so that free at-home tests can be mailed to you, hang up — it's a scam!
