## III. Community Correspondence -

A. Brian Shore spoke again about water in his basement. He claims that the slope of the retention rock wall funnels water into his basement and wants the wall moved 2 feet. The landscapers say the wall is good and doing its job.

A quote from Zanders to Brian was presented to the committee. Pictures show extensive cracks in his basement wall that need to be fixed. That responsibility is the homeowners. Because Tamarack has no obligation to repair the cracks which allow water in his basement, the matter is closed regarding the Maintenance Committee.

- A. The contract for deck at 11 Mountain Ash was signed. Contractors will break ground this year but won't finish the work until next spring.
- B. 66 Oak Creek is next. A quote with and without the steps was requested.
